## **EUAA Judicial Workshops 2024**




The EUAA judicial workshops are based on the <u>EUAA judicial</u> <u>publications</u>. More information on the topics covered and the structure of each workshop can be found in the catalogue of the <u>EUAA judicial</u> <u>workshops</u>.

In 2024, these workshops will take place at the headquarters of the EUAA in Malta, as well as in other Member States within the context of bilateral agreements with national judicial training bodies and/or operating plans. Most workshops will be conducted in English. When a different language will be used, it will be clearly indicated.

The EUAA judicial workshops last for 2 full days. Each workshop will be conducted by a pair of judicial trainers from different EU+ countries, and the format will encompass brief presentations on the subject, case studies, group discussions, and the sharing of relevant case law and best practices.

The workshops are designed for an attendance of around 20 participants, 25 being the maximum. Nominees will be informed of the selection results within the deadline set below. No travel arrangements should be made until a formal invitation has been issued. In most cases, the EUAA will contribute to the travel costs and provide for a daily subsistence allowance.
