



## Cooperation Plan 2020-2022 of eu-LISA and EASO

In light of the Working Arrangement between the European Asylum Support Office (EASO) and the European Union Agency for the Operational Management of Large-Scale IT Systems in the Area of Freedom, Security and Justice (eu-LISA) dated 4 November 2014, the Cooperation Plan operationalises joint activities between EASO and eu-LISA for the period 2020-2022.

The implementation of all the activities is performed on a best-effort basis and may be subject to the availability of resources in accordance with the applicable legal framework. EASO and eu-LISA (hereinafter referred to as 'the Agencies') shall bear their own expenses.

Towards the expiration of the Cooperation Plan 2020-2022, the Agencies will assess its implementation and decide on the way forward as appropriate.

EASO Operational Support Centre	eu-LISA Executive Support and Stakeholder Relation Unit (ESU) and Operations Department (OD)	eu-LISA provides <i>ad hoc support</i> to Member States at their request, where required by extraordinary security or migratory challenges or needs. In particular, eu-LISA provides <i>operational</i> and technical reinforcement in cases of specific and disproportionate migratory challenges at particular areas of the Member States' external borders characterised by large inward migratory flows. Such reinforcement is provided in hotspot areas through the deployment of relevant teams composed of experts from relevant European Union Agencies. The Agencies may plan and carry out pilot projects encompassing inter alia standardisation of equipment for migration management support teams (MMSTs), if relevant.

Should the legislation so allow, the Agencies will cooperate on the implementation of the Eurodac reform within the respective mandates of each Agency.

Asylum Knowledge Centre/ Administration Department – ICT Unit	ESU, GCU and OD (BRM)	The Agencies will map information processing maturity in the Member States (hereinafter referred to as 'MS'), gathering lessons learned and developing best practices with the aim of optimising asylum process flows as well as the integration and use of enterprise architecture principles into information systems and tools (national and EU- wide).  As envisaged in the Action Plan on Enhancement of Data Quality prepared in the context of the 5 <sup>th</sup> Information Management Strategy action list, the presence of high quality data in large-scale JHA IT systems, Eurodac included, shall be ensured. Therefore, this work shall contribute to the optimisation of processes and standards, including the unified message format (UMF).  The Agencies shall explore together, based on their expertise, and with the MS, innovative solutions including the use of Artificial Intelligence and machine-learning for technical practical tools used in the asylum procedure.
Asylum Knowledge Centre – Asylum Cooperation & Guidance Unit (EASO Dublin Team)	ESU, OD (BRM, Programme and Project Management Sector (PPMS))	The Agencies will continue their co-operation with regard to the operational management support to Dublin Units in MS through the work of the Steering Group and Working Groups of the EASO Network of Dublin Units, and through the organisation of the annual thematic meeting for the MS regarding DubliNet, and/or Dublin related technical systems.
Asylum Knowledge Centre – Asylum Cooperation & Guidance Unit (EASO Dublin Team)	OD (PSU), ESU, GCU	The Agencies may jointly develop recommendations, digital brochures and practical guides on the operational use of asylum-related IT systems, in particular those related to the Dublin procedure, such as Eurodac.  To this extent, eu-LISA will retain its status as observer to Steering Group of the EASO Network of Dublin Units. eu-LISA will invite as appropriate EASO representatives as experts to attend the Eurodac Advisory Group.

The Agencies will share best practices in the field of andragogy, including the use of e-Learning practices and quality assurance in the field of training. The possibility to provide access to each other's online training platforms, for officials of both agencies, should also be explored.

In particular, the Agencies may decide to organise a joint training module on data quality enhancement in large-scale JHA IT systems used in the asylum and migration fields as envisaged in the Action Plan on Enhancement of Data Quality prepared in the context of the 5 <sup>th</sup> Information Management Strategy action list.
